WEBSITE:

- BE: To transfer OUDS domain name costs money with Wix. £2.50 a month with domain name and ads. Goes up to £6 without adverts. Are we happy to pay the subscription. I've spoken to Samuel Littley. We have to pay for the domain anyway. CP: Are they ordered by week? BE: Do we order it by week or venue? CP: We should order it by week.
- FRESHER'S REPS: GF: What's the deal? JB: People need to email in and contact Josh.
- FUNDING: Charles is on it.
- CP: We should have a section about Edinburgh shows. MA: Ellie do you have pictures from NW. EL: Ask Becki.
- JT: Ellie can we get PDFs of newsletters? EK: I will look into it.

EDINBURGH SHOWS FUNDING

- CP: We've had some extra shows apply for funding.
- FOXTROT, SKETCHY HISORY, COLD/WARM
- COLD/WARM we're pretty confident with that one.
- SKETCHY HISTORY the guys are really nice and made good money on the BT show. We doubt that they'll make money but want to give them money anyway.
- FOXTROT they're quite solid; it could go either way.

EK: £800 is far too much for COLD/WARM. They chose to go to Pleasance. £800 is on par with the National Tour and is too much. CP: We could get lots of money back. MA: Has Flo taken anything up in the past? EK: Yes. 2 last year. One did quite well and the other made a loss. CJ: How big is the venue? CP: The breakeven is 40%. CP: They have a lot of connections. Flo was nominated for a writing award. EK: Are they in Pleasance Courtyard? CP: Their capacity is 58. EK: Will there be more shows applying throughout the term? CP: Most people will have confirmed numbers. MA: Why are we reducing it? EK: To make it like the other productions. EK: Ask Nicole what her system was. I don't know what the pool is like. CP: We're giving people money for deposits now. We'll reduce the funding to £700.

10/10 votes FOR, 0 ABSTAIN, 0 AGAINST all Funding decisions.

WEBSITE: Do we want to do the £2.50 or £6? CP: If we're not going to use the website it's a ridiculous price to keep paying. MA: How long do we have to pay for? BE: You have to commit for a year. RB: Would it affect the future committees? BE: They'd be tied to the domain, yes. They would be tied to the £2.50 a month. We need to get a really solid foundation – that's the point of having a designated website builder. If you have someone who's willing to put the time in it can be really professional. There are both simple and more complicated forms. I would be pushing for the £5.16 a month because the banners ruin the aesthetic. I'm sure everything else is worth it. We're paying to Buhgoo…?
